



2019 LSSC Sunset Race Series

Spring: May 15 – June 19 Summer: Aug 7 – Sept 11

Notice of Race

1. **RULES:** The series will be governed by the rules as defined in *The Racing Rules of Sailing*.
2. **ENTRY:** All entrants must be PHRF ratable yachts of conventional hull design with bunks and head, auxiliary power, self-righting, self-bailing cockpits and fulfill U.S. Coast Guard regulations. The LSSC Race Committee will assign a rating to any yacht without a valid rating certificate.

Eligible boats may enter by completing the Application, found at <http://www.LakeShoreSailClub.org>, and sending it with the required fee before the first race of the series.

3. **FEES:**

Spring:	\$70 (add late fee after May 10)
Summer:	\$70 (add late fee after Aug 2)
Both Series:	\$130
Late Fee:	\$25
4. **SCHEDULE:** Each of the two series will be run on six consecutive Wednesday evenings, with the first start at 1900 hours.

Spring Series: May 15, 22, 29, June 5, 12, 19

Summer Series: Aug 7, 14, 21, 28, September 4, 11

6. **RESULTS:** Individual Race results will be announced after each race at **Gilbert's Lodge**, 22335 Harper Ave., St Clair Shores. Any change in post-race meeting location will be announced prior to the race. All race results will be posted on: <http://www.LakeShoreSailClub.org>
7. **AWARDS:** First, Second, and Third place Series awards shall be given for each class. Overall awards shall be presented for each series as well as the combined series for the top three positions. These flags will be presented at **K of C Hall**, 25003 Little Mack, St. Clair Shores at 1900 hours on: **September 18, 2019**. Free beer, pop and pizza will be provided.
